Remember, the Compendium is just a recommendation, and many states still have to pass legislation or make complicated rule changes. Also, some states have no control over local health departments, resulting in a checkerboard of different policies across the state. If your state *is not* asterisked, we have a reliable public official stating that the Compendium is being followed. If your state *is* asterisked, there is a problem or delay of some kind. If you learn of a case where a ferret is killed contrary to the Compendium recommendations in a complying state, contact the person shown on this list, get the facts of the case from the state's point of view, and contact the AFA's Legislative and Legal Affairs Committee so we can take action. If you are interested in working on compliance in your state, let us know and we'll add you to our network.
